## RECOVERING AMERICA'S WILDLIFE ACT NEEDS YOUR HELP

The Recovering America's Wildlife Act, H.R. 2773, is reintroduced in both houses of Congress and now has over 85 cosponsors in the house! Supporters feel it has a good chance to pass this session.

H.R. 2773 would devote \$1.4 billion annually to wildlife conservation across the country, over \$50 million per year here in Texas. Texas Parks and Wildlife Department has identified almost 1300 Species of Greatest Conservation Need in Texas. TPWD would distribute these federal funds to organizations, agencies, and private landowners for habitat restoration, land acquisition, research, and education, to stabilize wildlife populations and keep them off the endangered species list.

"The economic benefits of the Recovering America's Wildlife Act are huge," says John Shepperd, from the Texas Foundation for Conservation. "Texas wildlife form the basis of our \$35 billion outdoor recreation industry and provide \$9 billion worth of pollinator services to our agriculture."

## CONSERVATIONISTS & LOCAL INTERESTS ORGANIZING AGAINST MARVIN NICHOLS RESERVOIR

Promoters of the Marvin Nichols Reservoir claim it takes thirty years to get a reservoir permitted and built, and they've moved the timeline for completion forward to 2050. This sounds like the project is about to move. In response, conservationists, landowners, timber industry reps, and other community leaders have launched a new initiative to <u>Stop Marvin Nichols</u>.

Marvin Nichols Reservoir would permanently flood 66,000 acres of prime bottomland hardwood forest and ag land, force thousands of Texans to sell their land and hundreds to watch their homes destroyed, and cause a huge negative impact on the economy of Northeast Texas. At least 80% of the water would be piped 100 to 170 miles to the DFW area.

TCA Vice Chair Richard LeTourneau and Policy Director Janice Bezanson are in the thick of opposing this unnecessary reservoir.

"There are so many better ways DFW could get future water," says Richard. "Municipal water recycling would be the best way. Additional water conservation is another. And there are existing reservoirs – Lake Texoma and Toledo Bend – with a lot more water available than Marvin Nichols would provide."

#### INTERNSHIP DETAILS

TCA offers 10-week internships every semester. The deadline to apply for the fall semester is August 28, 2021. Spring 2022 applicants must apply by February 5, 2022. TCA internships require approximately 10 hours of service each week, including occasional weekends. TCA hosts interns across the state and most work is conducted remotely with weekly professional development sessions and check-in meetings with staff mentors. TCA requires applicants be at least 18 years of age and be eligible to work in the U.S.
